The undersigned acknowledges that off roading is inherently dangerous and can pose a risk to vehicles, drivers, and passengers. You travel at your own risk! If you do not feel comfortable undertaking these risks, then please do not go on this run.

Common vehicle damage may include punctured tires, paint scratches from cactus and shrubs, maybe a dent. However, there is always a risk of greater damage, resulting from constantly evolving trail conditions or the fragility of automotive components. Although the trail leaders will do their best to offer safe guidance, there are no guarantees. Every vehicle and driver is different. Desert Wranglers is not a commercial tour business. We are a not-for-profit club, and all of us are volunteers. Participation in any and all Desert Wranglers activities, be they Jeep related or other social events, is voluntary and completely at your own risk.

To the extent permitted by law, the undersigned, covenants to save, defend, keep harmless and indemnify Desert Wranglers Jeep Club and all of its officials, consultants, agents and volunteers from and against any and all claims, loss, damage, injury, cost (including court costs and attorney's fees), charges, liability or exposure, however caused, resulting from or arising out of or in any way connected with the activities required to successfully complete an off-road trail run or other club event. It is further understood and agreed that the undersigned are not employees of Desert Wrangler Jeep Club and are not eligible for Worker's Compensation benefits should the undersigned or his/her guests be injured while participating in any Desert Wrangler Jeep Club off-run trail run or other club event.
